# Frontline Service #1: ISSUANCE OF A MOTORIZED TRICYCLE OPERATORS PERMIT

#### **About the Service**

Subject to the guidelines prescribed by the Department of Transportation and Communication, regulates the operations of tricycles and grant franchises for the operations thereof within the Territorial Jurisdiction of the municipality.

#### Requirements

#### A. Franchise and Mayor's Permit:

- 1. Barangay Clearance
- 2. Voter's ID
- 3. Certification from Association of Tricycle Operators and Drivers
- 4. Residence Certificate Number of Owner (Cedula)
- 5. Old Franchise and Mayor's Permit
- 6. SB Inspection
- 7. Registration of Ownership/Certification of Ownership
- 8. SSS/PHILHEALTH Clearance

#### Validity:

Franchise : three (3) years.

• Mayor's Permit : until December 31 of the current year

#### B. Dropping of Franchise

- 1. Official Receipt
- 2. Certification of Ownership or Old Franchise
